# GENERAL TERMS AND CONDITIONS VSV FRESHMEN WEEKEND 2018

### **APPLICABILITY**

The general terms and conditions outlined in this document apply to the VSV Freshmen Weekend 2018 (the event). The organization of the VSV Freshmen Weekend is under responsibility of the Society of Aerospace Engineering Students VSV 'Leonardo da Vinci'. The agreement that is formed by accepting these terms, is formed between the person ordering the ticket (the participant) and the organization of the VSV Freshmen Weekend 2018 (the organization).

### ARTICLE 1: THE REGISTRATION PROCESS

- 1.1 The participant is responsible for correctly filling out the application form. Disputes resulting from an incorrect completion of the application form will always be decided in favor of the organization.
- 1.2 People can only register for the event in case he/she will be a first year student at the faculty of Aerospace Engineering of the University of Technology in Delft in the upcoming academic year (2018-2019).
- 1.3 Personal information submitted by the participant will be saved in the database of the organization. Personal information will not be made available to third parties. Data submitted by the participant will only be used for this event.

## **ARTICLE 2: PAYMENT**

2.1 Everyone wishing to participate in the event is required to pay the full price of the ticket online before the start of the event.

# **ARTICLE 3: TICKETS**

- 3.1 The ticket obtained by the participant may never be sold to third parties.
- 3.2 Being in the possession of a valid ticket in name of the participant guarantees the admittance to the event, providing all of the conditions stated in this document are met by the participant.
- 3.3 At the beginning of the event, the participant is required to produce a ticket in his or her name and a valid form of identification.

## **ARTICLE 4: LIABILITY**

4.1 Participating in the event is at own risk.

4.2 The organization is in no way responsible for any physical harm, material damages or lost items during the event.

### ARTICLE 5: FORBIDDEN SUBSTANCES

- 5.1 All participants are forbidden to take alcohol or other drugs to the event. Also forbidden is the possession of (fire)arms during the entire course of the event.
- 5.2 Under Dutch law underage participants (meaning participants under the age of 18), it is not allowed to consume any alcoholic beverages during the event.
- 5.3 Passing on alcoholic beverages to underage participants by participants over the age of 18 is strictly forbidden. Ignoring this rule can lead to exclusion of further participation as described in article 6.3.

## ARTICLE 6: BEHAVIOR OF THE PARTICIPANTS

- 6.1 During the entire event, participants directly have to follow instructions given to them by the organization.
- 6.2 Instructions from the personnel present on the grounds where the event takes place are to be followed by the participants as well.
- 6.3 The organization reserves the right to remove participants from the event in case they fail to follow instructions given to them by the organization and, in the eyes of the organization, it is vital for retaining good order during the event. In such an event, the participant is not entitled to restitution of the subscription fee paid upon purchase of the ticket.

## **ARTICLE 7: DEREGISTRATION**

- 7.1 The participant is able to cancel the registration until the 5<sup>th</sup> of August 2018. In this case the organization will have to refund the full registration fee.
- 7.2 For a cancellation after the 5<sup>th</sup> of August 2018, a refund can be requested but a full refund cannot be guaranteed by the organization.
