Treasurer Lagerweij: We noticed that the tariff for driving the sprinter did not cover the maintenance, fuel, and other variable costs. It was discussed in the GTO, €2000 was taken out from the VSV budget. These are the new tariffs (excl. VAT):

- €0,45 per kilometer low
- €0,60 per kilometer high

22. SAF sustainability update

Member of Merit Jelle Kok presents the sustainability update.

At the next GMA a vote will be held on the new sustainability policy We are currently using the milieudefensie list, but it has drawbacks From now on, the step list will be used.

If it does not pass the step method, there are additional questions to keep the conversation going.

Senator Janssen: is it possible to change the form to not have a double denial **Member of Merit Jelle Kok:** I will change it to 'in an unsustainable'

Senator Greeve: The thing that is most unclear is which sector is unsustainable. An automotive company can also make electric cars.

Member of Merit Kok Jelle: There is a possibility for an input session, but there needs to be animo for this.

Senator Honing: Has it been tried before to send out a form? Or standing in the main hall and giving out mars bars?

Member of Merit Jelle Kok: No, that has not been done yet

Senator Breddels: Does the ESG consider scope 1,2,3?

Member of Merit Jelle Kok: With Most of the ESG ratings, there is no explanation on how the score is calculated.

Senator Buijvoets: How much time do we have left on the timer?

President van Luik: 8 minutes!

23. Voting on the revised Studytour regulations

- Already voted for Studytour 43 onwards → they are in group 2 (only possible to sign up if group 1 not filling for places available)
- What happens now to Studytour 42 and older?

- The Study tour Committee member knows what the selection procedure looks like, and that that is unfair to other VSV members because they have already been on a Study tour, and they even got to design their own Study tour
- + You were organization so you couldn't really enjoy it
- Everyone who is currently part of the Studytour committee and everyone who was part of it.
 - It was not clear for past Studytour that they would be group 2 (during registration at 79)
 - For Studytour 41 and backwards everyone thought that they would be able to go on a study tour again as a participant and considered in group 1
 - Something that is good to know is that the Studytour committee was always considered as group 3.

We will not consider 42 as single group; we vote for 42 and all backwards

Diede van Rheede: As it says now, 42 says current, but they have not been installed yet. **Commissioner of Master Affairs Valk:** The number says that they are working on organizing a Study tour for the coming summer. This will be changed in the minutes.
